## **BYLAW NO. 805 - 2018**

## **CAMPGROUND BYLAW**

Being a bylaw of the town of Fox Creek, in the Province of Alberta to establish rules, regulations and fees for the operation of all Fox Creek Campgrounds.

WHEREAS Council of the Town of Fox Creek, in the Province of Alberta, under the authority of the Municipal Government Act, being Chapter M-26 of the statutes of Alberta and amendments thereto may pass by-laws for the purpose of regulating and operating a municipal campground within the Town of Fox Creek

NOW THEREFORE, the Municipal Council of the Town of Fox Creek duly assembled enacts as follows:

- The Town Chief Administrative Officer of the Town of Fox Creek shall be responsible for the management of the Fox Creek campgrounds in accordance with this Bylaw and the regulations regarding the campgrounds operations as established by the Council of the Town of Fox Creek and by the Government of Alberta (for Iosegun Lake and Smoke Lake).
- Regulations for the operation of the Fox Creek Campgrounds are hereby adopted as outlined on Appendix "A" attached to this Bylaw. The Council of the Town of Fox Creek may amend these regulations by resolution when it is deemed appropriate by the Council, without the need to repeal or amend this Bylaw
- 3. The Bylaw Enforcement Officer, for the Town of Fox Creek or a Peace Officer may enforce this Bylaw by such measures as deemed necessary to ensure the Bylaw is complied with, including the issuance of tickets or eviction from the campground as outlined herein.
- 4. The Bylaw Enforcement Officer, authorized by the Town Chief Administrative Officer, or a Peace Officer may evict an individual or group of individuals from the Fox Creek Campgrounds if those individuals are creating a nuisance, or in breach of this Bylaw or its regulations, or if they are interfering with the quiet enjoyment of other campers.
- 5. (a) Any person contravening any provision of this Bylaw shall be liable upon conviction therefore to a fine of not less than \$500 and not more than \$1,000 exclusive of costs, in case of non-payment of the fine and plus costs so imposed; and
  - (b) Where the offence is non-payment of any camping fees as established by the regulation, the payment of the camping fee shall be in addition to the fines and penalties imposed. Fines and penalties are as defined in Bylaw No. 800 2017, the "Fees and Charges Bylaw."

This Bylaw shall come into force upon final passing thereof and upon taking effect, Bylaw 729 – 2013 is repealed.

## Appendix "A"

Regulation for Operation of Fox Creek
Operated Campgrounds & RV Campground

Please note: All regulations established under the Provincial Parks Act, Provincial Parks (General)
Regulations apply to the lands set out in both Smoke Lake Provincial Recreation Area (PRA) and losegun
Lake PRA.

Drive Cautiously: Children may be playing in the area and Campground roads are

used as paths. Maximum speed is 20km/h.

Keep campsites clean: Clean up all garbage, cans & food so that it does not attract animals

and keeps the site neat and tidy.

Be careful with your campfire: Your negligence could result in a destructive forest fire, Campfires

are permitted in fireplaces only and must be attended at all times.

**Enjoy your campfires here:** Firewood is provided for your convenience, only to be used on site.

Share the facilities: Shower & Washrooms may not be used in such a way that limits

use by others.

Be considerate of others: All campers must refrain from rowdy behaviour and excessive

noise. No generators between the hours of 2300 and 0700.

Control your pets: To protect your pet, local wildlife and other campers, your pets must

be on a leash during your stay.

Keep all vehicles on designated

roads:

Trees and greenery are what beautifies the Campground. By wandering off roads, your vehicle kills plants and damages tree roots.

Resulting in patches of bare soil.

Off Highway vehicles may not be operated on the campground (a direct route from campground/staging area to designated trails that

leads out of the Provincial Recreation Area may be created).

Recreation areas are Not for

shooting:

Discharging firearms or the use of any weapon (knife, spear, bow and arrow, etc.) is strictly prohibited in all campground and within the

Town boundaries.

Firearms are to be unloaded and encased while in Smoke Lake and

losegun Lake campgrounds / PRA's.

Dressing, hanging or storing of big game shall not take place in the

campground.

Use, but do not Abuse: Enjoy the natural beauty and recreation facilities here, but please

protect them for your next visit and for other campers.

Trails are provided for your

enjoyment:

Stay on designated trails and use them only for the activity for which

they are intended.

**Equestrian users:** Horses are not allowed into the campground.

Fees: Refer to Bylaw No. 800 – 2017.

Right of Entry Town of Fox Creek employees, Peace Officer or RCMP may enter

the

premises and/or the property if it is deemed necessary to do so.

Services are not for Communal

use:

It is not permitted to have more than one (1) unit utilize any of the services provided (power, water, sewer). The Town may allow this to be overridden, however, there will be additional fees attached to

this exception.

Violation of any of the above rules may result in a charge and/or eviction by a Town of Fox Creek Employee, Peace Officer, or the RCMP.
