



**PUBLIC NOTICE  
HEAVY TRUCK PERMIT FEES**

The Town of Fox Creek has undertaken an extensive revision of Traffic Control Bylaw 806-2018 and TRAVIS Bylaw 799-2017, as well as replacing Road Use Agreement 804-2018 with Road Use Agreement 812-2018.

The revision has resulted in the removal of sections 3.3 *Over-Dimensional Permit* and 3.6 *Multiple Legal Load Permit*.

We would also like to reassure you, a permit is NOT required if you are passing through the area. If you are travelling on Highway 43, and want to stop for fuel, food, parts, or emergency repairs, you will **not** need a permit.

A revised Permit Fee Schedule is posted below this notice.

The date for the implementation of the new truck permit fees is August 1, 2018.

Although not available at this time, we are working towards implementing an ecommerce system where you will purchase the permits, not available on the TRAVIS system, through Town of Fox Creek Website.
