


Community Priorities

Priority 1	Crime Reduction Initiatives - Reduce Persons and Property Crimes
Current Status & Results	A new detachment initiative is underway in identifying two prolific offenders from the community for enhanced policing efforts in deterring their criminal behavior and thus reducing calls for service. A search warrant was executed at a residence in Fox Creek that was successful in recovering stolen property as well as a prohibited firearm. One individual remains in-custody as a result from this, which has impacted our calls for service and theft of property complaints.
Priority 2	Engage with Local Community
Current Status &	Constable DORSEY is new to the Enhanced Policing position and is the designated school liaison officer. Constable DORSEY has been able to make multiple appearances at the school since beginning of September and has presented about on-line safety, provided a career presentation, and conducted meet-and-greet with the younger grades.

Results Sgt BRAND and Cpl DEIBERT attended City Council meeting on August 30th to present on crime stats for the month. Members of the detachment attended and supported the First Responders Charity golf tournament in raising funds for the Burn Unit. On September 25, Cst WHITE was in attendance at the Big Iron Event in town. Future events in quarter three have the detachment participating in the Trick or Treat event at the multiplex.

Priority 3	Training and Development of Members
Current Status & Results	The training opportunities continue to be impacted by covid restrictions; however, on-line based training through MS Teams as well as internal platforms has allowed for on-going development for the members. Every member recently completed nine courses that will assist with their day-to-day duties as the material ranged from Effective Decision Making, Note Taking, Search and Seizure, Interviewing and Court Testimony. In-house training was completed in October for all members to be certified for use on the alcohol roadside screening devices. This will allow for a detachment impaired driving enforcement initiative in quarter three.

Trends/Points of Interest

The changes from the same reporting last year are positive as we see a reduction in calls for service as well as reduction in persons crimes. Property crime continues to be a concern as we are seeing on-going thefts from oil field and well sites around the area. On-going efforts and consultation are being made in partnership with Pembina, Repsol and Paramount on what actions can be taken to deter these thefts as well as what efforts can be made to capture evidence of the offenders committing these crimes.
