POSITION SUMMARY

The role of a Part Time Lifeguard is to ensure the safety of patrons in the swimming area of the Chevron Aquatic Centre, located in the Fox Creek Greenview Multiplex. Lifeguards are responsible for performing lifeguarding roles and responsibilities as outlined in the policies and procedures. They must participate in ongoing staff in-services, training, and development programs. Lifeguards also assist with maintenance and cleanliness of the pool and associated areas, as well as completing any other duties as assigned.

RESPONSIBILITIES

Shall be required to adhere to process and policies in support of municipal goals and legislative requirements.

- ◆ Practice of required safety procedures, and in cases of emergency perform basic first aid, water rescues and required to learn other lifeguarding skills, and techniques as necessary
- ◆ Maintaining general pool cleanliness and regular maintenance duties
- ◆ If certified, instruct programs such as swimming lessons, fitness classes and so on
- ◆ Assisting facilitators with programs such as swimming lessons, fitness classes and so on
- ◆ Obtain and maintain required certification
- ◆ Communicate effectively with the public, supervisors and coworkers
- ◆ Completion of other administrative duties as assigned
- ◆ Other duties as assigned

QUALIFICATIONS

Must:

- ◆ Lifesaving Society's (or equivalent) - Bronze Cross
- ◆ Standard First Aid/CPR "C"/AED or Emergency First Aid
- ◆ Provide a an acceptable Criminal Record Check or Vulnerable Record Check
- ◆ Be able to work in environments involving some exposure to hazards or physical risks, which require following basic safety precautions
- ◆ Work may involve moderate exposure to unusual elements, such as dirt, dust, fumes, unpleasant odors, and/or loud noises.
- ◆ Be able to read, write, speak and understand English
- ◆ Be physically fit
