

BYLAW NO. 813-2018

OF THE TOWN OF FOX CREEK

BEING A BYLAW OF TOWN OF FOX CREEK IN THE PROVINCE OF ALBERTA TO AMEND TOWN OF FOX CREEK BYLAWS NO. 799-2017 AND 806-2018;

WHEREAS the *Traffic Safety Act*, RSA 2000, c. T-6, authorizes a municipal council to, with respect a highway under the municipality's direction, control and management, make bylaws that are not inconsistent with the *Traffic Safety Act*;

WHEREAS the Council of the Town of Fox Creek deems it desirable to amend Town of Fox Creek Bylaw No. 799-2017 ("Collection of TRAVIS Fees") and Town of Fox Creek Bylaw No. 806-2018 ("Traffic Control Bylaw");

NOW THEREFORE the Council of the Town of Fox Creek in the Province of Alberta hereby enacts as follows.

- 1. The Town of Fox Creek Bylaw No. 806-2018 ("Traffic Control Bylaw") is hereby amended as follows:
 - a. Section 2.7.1 of the Traffic Control Bylaw is amended by deleting "unless a permit to do so has been issued by the Designated Officer";
 - b. Section 3.3 (Over-weight and Over-dimensional Permits) of the Traffic Control Bylaw is amended as follows:
 - i. Section 3.3.1 is amended by deleting "or dimension";
 - ii. Section 3.3.2 is amended by deleting "Over-Dimensional Vehicles and";
 - iii. Sections 3.3.3 and 3.3.4 are deleted in their entirety.
 - iv. Schedule II(B) (Over-Dimensional Permit) and Schedule II(C) (Annual Over-Dimensional Permit) to the Bylaw are deleted in their entirety.
 - c. Section 3.6 (Multiple Legal Load Permits) of the Traffic Control Bylaw is deleted in its entirety, and
 - d. Minor housekeeping amendments.
- 2. The Town of Fox Creek Bylaw No. 799-2017 ("Collection of TRAVIS Fees") is hereby amended as follows:
 - a. The preamble to the Collection of TRAVIS Fees Bylaw is amended as follows:
 - v. By deleting "and over-dimensional" from paragraph 1 of the preamble;
 - vi. By deleting "and size" from paragraph 2 of the preamble
- 3. If any section, subsection, sentence, clause or phrase of this bylaw, or the bylaws amended by this bylaw, is for any reason held to be invalid by the decision of any Court of competent jurisdiction, the decision shall not affect the validity of the remaining portions of this bylaw or the bylaws amended by this bylaw.
- 4. This Bylaw shall come into force and effect upon the third and final reading of this Bylaw.
