# THE CORPORATION OF THE TOWN OF FOX CREEK, ALBERTA BYLAW 881-2024

Being a bylaw of the Town of Fox Creek, in the Province of Alberta for the establishment of Fees and Rates for goods and services provided by or on behalf of the municipality.

**WHEREAS**, the *Municipal Government Act, Chapter M-26, Revised Statues of Alberta, 2000* provides that Council may pass bylaws for municipal purposes respecting the safety, health and welfare of people, services provided by or on behalf of the municipality and the enforcement of bylaws;

**AND WHEREAS**, the Council of the Town of Fox Creek deems it necessary to establish fees and rates for the Multiplex.

NOW THEREFORE, the Council of the Town of Fox Creek duly assembled enacts as follows:

#### 1. SHORT TITLE

1.1. This bylaw may be cited as the "Fees & Rates Bylaw – Multiplex"

#### 2. **DEFINITIONS**

- 2.1. ACT shall mean the *Municipal Government Act*, RSA 2000,c.M-26.
- 2.2. **CAO** shall mean the Chief Administrative Officer for the Town of Fox Creek or their designate.
- 2.3. **COUNCIL** shall mean the duly elected Council of the Town of Fox Creek.
- 2.4. **FAMILIY DROP IN** shall mean 2 adults, age 18+ and up to 3 children, age 17 years and younger, individuals may or may not reside in the same household.
- 2.5. **FAMILY MEMBER** shall mean 2 parents or guardians, age 18+, and up to 3 children, age 17 years and younger, and all must reside the same household.
- 2.6. **GENERAL ADMISSION** shall mean access to facilities within the Multiplex. This includes entry to the swimming pool, workout rooms, field house, running track and arena for shinny and public skate.
- 2.7. **LESSONS** shall mean sessions led by an instructor, designed to impart knowledge or skills and are often part of a broader curriculum or training program.
- 2.8. **MEMBERSHIP** shall be defined as the purchase of either a 6-month or annual pass. This membership not only grants access to the multiplex facilities but also entitles members to exclusive discounts on various programs and lessons offered by the multiplex.
- 2.9. MULTIPLEX shall mean the Fox Creek Greenview Multiplex recreation facility.
- 2.10. **NON-PRIME TIME** shall mean the hours when the facility experiences lower usage and demand.
- 2.11. PERSON shall mean any individual, corporation, society, association, partnership or firm.
- 2.12. **PRIME TIME** shall mean the periods during which the facility experiences the highest demand and usage by its members and visitors.
- 2.13. **PROGRAM** shall mean a series of recreational sessions led by an instructor, designed to impart specific knowledge or skills, and are independent of any broader curriculum or training program.

- 2.14. SPORT ACTIVITIES shall mean any sporting events, competitions, or activities that are organized by local chapters of provincial, national, or international organizations and/or sports leagues. This also includes sporting activities that are organized by a Person.
- 2.15. **TOWN** shall mean the Town of Fox Creek.

#### 3. FEES & RATES

- 3.1. Fees & Rates for municipal services for the Multiplex shall be levied according to "Schedule A" which shall form part of this Bylaw.
- 3.2. Fees for lessons and programs shall be determined as per Policy.

#### 4. 10 PUNCH CARD ADMISSIONS

- 4.1. Each card is valid for 10 admissions and can be used by any individual within or younger than the designated age group of the punch card.
- 4.2. The card must be presented at the time of admission.

#### 5. MEMBERSHIP

5.1. Memberships are strictly non-refundable and non-transferable.

#### 6. FACILITY USE AND CLEANING

- 6.1. Persons using Town-owned facilities are required to clean up after themselves to maintain the cleanliness and order of the premises. This responsibility includes disposing of trash, tidying up any used spaces, and ensuring that the facilities are left in the same condition as they were found.
- 6.2. Persons not abiding to 5.1 shall be charged a fee for Janitorial services as per "Schedule A" and may be subject to lose the privilege for future rentals of Town Facilities.

#### 7. EXPIRY

- 7.1. 10 Punch Card Passes: Shall expire within a twelve-month period from the date of issuance. For those punch cards that were issued without an expiry date prior to the passage of this bylaw, the twelve-month validity period will commence from the date of this bylaw's passage.
- 7.2. One-Month Passes: Shall expire one month from the date of purchase.
- 7.3. Six-Month Passes: Shall expire six months from the date of purchase.
- 7.4. Annual Passes: Shall expire twelve months from the date of purchase.

#### 8. CANCELLATIONS

- 8.1. Persons renting the field house, rooms, ice or the pool shall be required to give in writing 24 hours notice of cancellation.
  - 8.1.1. With 24 hours notice the full rental amount shall be refunded.

- 8.1.2. Cancellations made with less than 24 hours notice may be subject to a charge of up to 50% of the rental fee, at the discretion of the CAO.
- 8.2. The Town holds the right to cancel rentals in the case of emergency, pandemic or major incident. The full rental amount shall be refunded.

#### 9. INSURANCE

- 9.1. Rental Insurance is required all Sport Activities.
- 9.2. The Town of Fox Creek shall be named as an additional.

#### 10. SEVERABILITY

10.1. Every provision of this Bylaw is independent of all other provisions, and it is the intention of the Council that if any provision of this Bylaw is declared invalid by a court of competent jurisdiction, all other provisions of this Bylaw shall remain valid and enforceable.

#### 11. EFFECTIVE DATE

- 11.1. This Bylaw 881-2024 comes into full force and effect on Jenuary 1,2005
- 11.2. Bylaw 845-2020 and any associated amendments are hereby rescinded.
